



Memorandum of Agreement

BETWEEN

FACULTY OF BIOLOGY, UNIVERSITAS NASIONAL, INDONESIA, an institution of higher learning, established under the laws of the Republic of Indonesia, having its address at Sawo Manila Street, Number 61, Pasar Minggu, Jakarta Selatan 12520, Indonesia;

AND

FACULTY OF FORESTRY AND ECOLOGY, POLISSIA NATIONAL UNIVERSITY, UKRAINE, an institution of higher learning, established under the laws of the Republic of Ukraine, having its address at Staryi Blvd 7, Zhytomyr 10008, Ukraine;

WHEREAS

UNAS and PNU have agreed to develop links with each other and look forward to a long and successful collaborative relationship which is hoped will be of great benefit to all parties.

This MoA has been drawn up following preliminary discussions held between UNAS and PNU. This MoA is intended to record on a non-legally-binding basis, the terms upon which the Parties intent to collaborate in areas of mutual interest.

1. PURPOSE OF MOA

The Purpose of this MoA is to strengthen ties between UNAS and PNU, particularly between the UNAS' Faculty of Biology and PNU's Faculty of Forestry and Ecology and to promote academic collaboration and understanding of cultures between Indonesia and Ukraine.

2. SCOPE OF ACTIVITIES

The scope of the activities of the MoA shall include:





a) Students' Program

UNAS and PNU will seek opportunities to hold exchange of students a semester to take courses/conduct research and Indonesian and Ukranian Language student exchange programs which will include one semester at both institutions and the provision of library access and academic assistance. Such exchanges shall be negotiated and agreed to by Parties on a case-by-case basis.

b) Academic Staff Program

Visits by academic staff from both Parties will be encouraged for the mutual benefit of the parties.

The host Party will assist in arranging accommodation, immigration, language, and local custom for the visiting scholar.

c) Collaborative Research and Joint Publication

UNAS and PNU will seek opportunities to cooperate in research and joint publication. The universities will seek funding opportunities to cooperate in this area of research and joint publikation.

The details of further specific research areas will be determined by the mutual agreement of the Parties.

3. COSTS

UNAS and PNU shall each bear its own costs and expenses in fulfilling this MoA.

4. EFFECTIVE DATE, DURATION, TERMINATION

The MoA shall commence on the last date of signature hereof and shall continue for a period of five (5) years (2020-2025), unless terminated in advance by either Party. This MoA may be extended by written mutual consent of the Parties.

The MoA may be terminated by either Party by giving written notice at least six (6) months in advance to the other Party. The termination of this MoA will not affect participants from completing their activities at the host institutions.





The MoA is entered into English, Ukrainian, and Indonesian, each version shall be equally authentic and in the event of conflict or misinterpretation, the English version shall prevail. The MoA is made in two (2) copies), each having the validity of the original.
